LOCATION

The subject property is located within Snowdrop Industrial Estate off Club Road in Clondalkin.

7km from Dublin City Centre



PROPERTY DESCRIPTION

The subject property comprises an end of terrace warehouse investment of approx. 630 sq.m. (6,787 sq.ft.) excluding two substantial mezzanine levels extending to approx. 671 sq.m. (7,222 sq.m.). The property comprises a warehouse/industrial building of steel portal frame construction, double skin metal deck roof incorporating translucent panels and roller shutter door with loading access. There is ample parking to the front of the unit.

Internally the unit is in use with retail warehouse configuration at ground and mezzanine level, ancillary trade counter, showroom, meeting rooms, kitchen, WC and shower accommodation provided.




